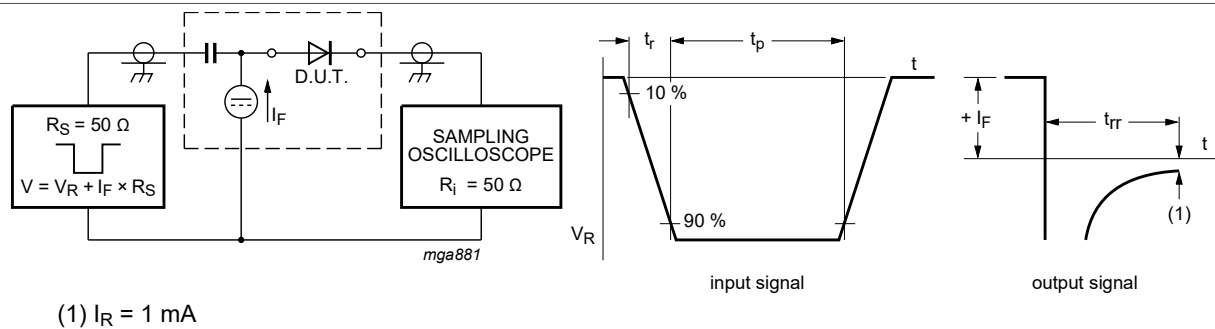


Fig. 4. Reverse recovery time test circuit and waveforms

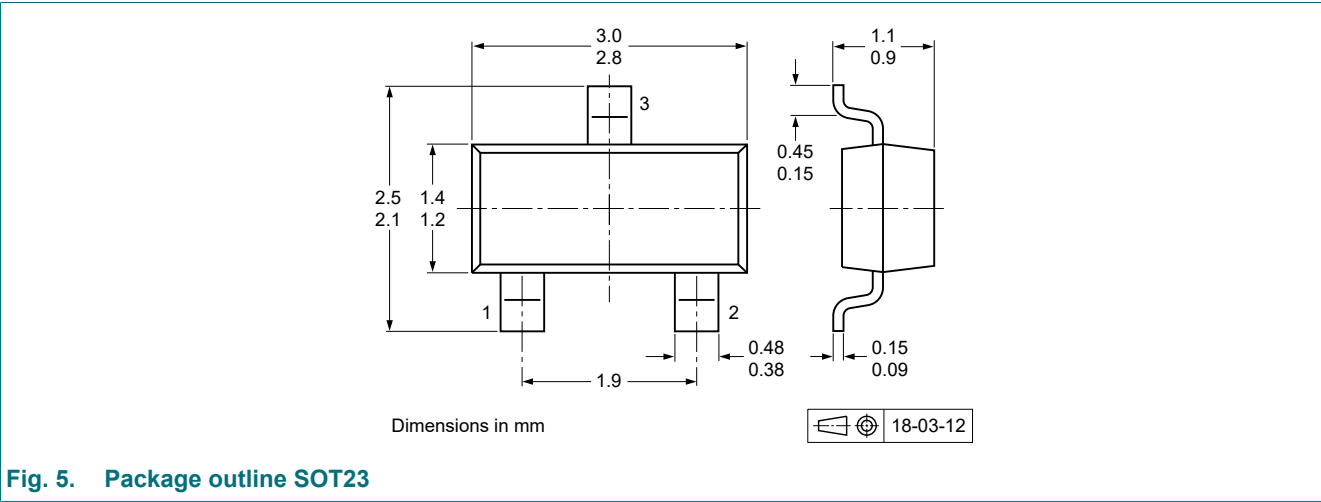


Fig. 5. Package outline SOT23

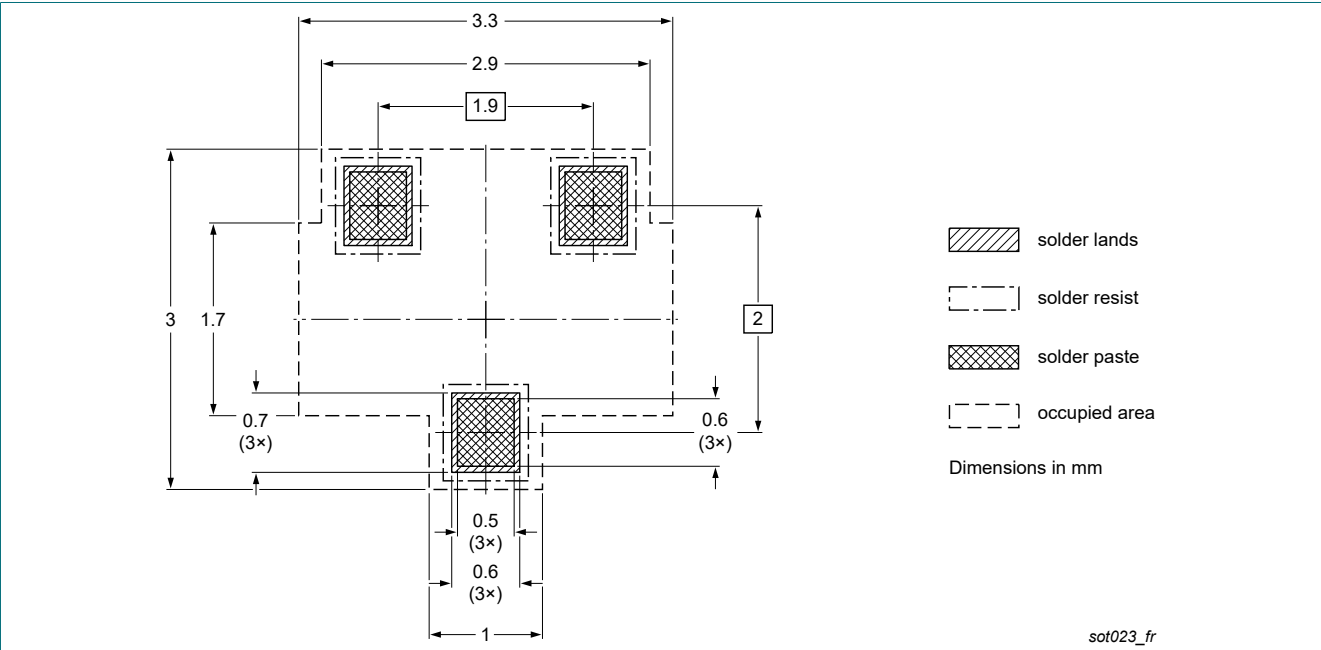


Fig. 6. Reflow soldering footprint for SOT23

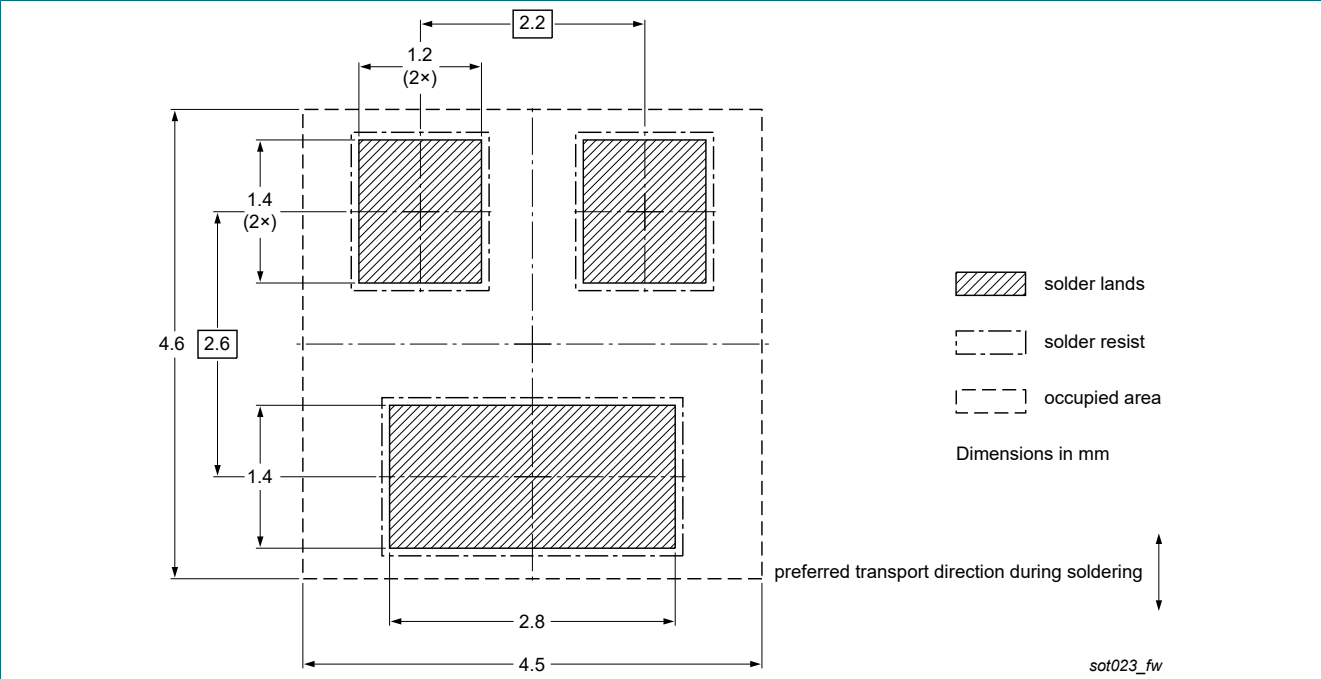


Fig. 7. Wave soldering footprint for SOT23
