Product specific:

Cleaning and Washing:

- Washing agents used during the production to clean the customer application might damage or change the characteristics of the component. Washing agents may have a negative effect on the long-term functionality of the product.

Potting:

To ensure this moisture level, the product either has to be stored in the original sealed packaging or needs to be stored in a humidity and temperature controlled storage room. Otherwise, the product may lose the required moisture level and its mechanical properties. 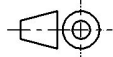
Packaging:
