Pink antistatic bags have the ability to dissipate a static charge to the ground preventing static charge building up on the package or device. The material is also antistatic and will not generate a charge when rubbed against other materials. These bags have no shielding ability. A static field or discharge occurring outside the bag could penetrate the bag and damage electronics inside.
